one dilemma facing new or newly independent states such as those of the former soviet union is how to design effective legislatures when political parties are weak and fragmented or even nonexistent in this book joel m ostrow develops a comparative institutional framework to explain marked differences in behavior across three post soviet legislatures the russian supreme soviet the russian state duma and the estonian legislature he argues that these differences in ability to manage political conflict can be explained in large measure by the design of the legislatures most significant is the choice of whether and how to include parties or partisan factors legislatures are an omnipresent component of modern democracy ostrow s comparative institutional design confirms the presumption of many political scientists that parties are essential for legislative consensus building however it also reveals that parties may have paradoxical effects on a legislature s performance in following the budget process in russia and estonia ostrow explores the consequences that different institutional

designs have had on post soviet legislatures he has found that how parties are included may determine how capable a legislature is at managing political conflict both internally and with the executive branch of the government the author was present at many of the committee hearings and legislative sessions he describes and his firsthand observations and interviews with committee members enhance his analysis

this book uses the early twentieth century surveillance reports of urban vice reformers in new york chicago lancaster pennsylvania as well as the us vice report for the league of nations special body on trafficking in women and children from 1927 and french police memoirs treatises and histories of vice enforcement in late nineteenth century and early twentieth century paris to highlight the way in which american reliance on undercover tactics drove american vice enforcement policy leading to a clash with french vice enforcement policy before the league of nations both the failure of that early effort to exert international influence on vice enforcement and the american embrace of undercover tactics would set the stage for the later american efforts to promote a global war on drugs before the league of nations in particular the american delegation s notable lack of success in mobilizing european crackdowns on prostitution created a blueprint for how not to project american influence overseas once american advocates of narcotics interdiction sought to promote a global war on drugs yet private reformers reliance on undercover tactics to investigate prostitution modeled the investigative tactics on which american law enforcement would come to depend and which it would later seek to export as a primary weapon in the war on drugs

abstract the thesis project is an investigation of some well known machine learning systems and evaluates their utility when applied to a classification task from the field of human genetics this common disease research task an inquiry into genetic and biochemical factors and their association with a family history of coronary artery disease cad is more complex than many pursued in machine learning research due to interactions and the inherent noise in the dataset the task also differs from most pursued in machine learning research because there is a desire to explain the dataset with a small number of rules even at the expense of accuracy so that they will be more accessible to medical researchers who are unaccustomed to dealing with disjunctive explanations of data furthermore there is assymetry in the task in that good explanations of the positive examples is of more importance than good explanations of the negative examples the primary machine learning approach investigated in this research is genetic algorithms ga s decision trees autoclass and cobweb are also included the ga performed the best in terms of descriptive ability with the common disease research task although decision

trees also demonstrated certain strengths autoclass and cobweb were recognized from the onset as being inappropriate for the needs of common disease researchers because both systems are unsupervised learners that create probabilistic structures but were included for their interest in the machine learning community these systems did not perform as well as ga s and decision trees in terms of their ability to describe the data in terms of predictive accuracy all systems performed poorly and the differences between any two of the three best systems is not significant when positive and negative examples are considered separately the ga does significantly better than the other systems in predicting positive examples and significantly worse in predicting negative examples the thesis illustrates that the investigation of real problems from researchers in other fields can lead machine learning researchers to challenge their systems in ways they may not otherwise have considered and may lead these researchers to a symbiotic relationship that benefits multiple research communities
